Credit Application - Terms and Conditions

To: Freshmax NZ Limited

I/We hereby apply for you to extend me/us credit in relation to payment for services provided by you on the terms detailed below. Full details of our organisation are set out overleaf.

- A. I/We agree that your terms of trading are payment within (7) seven days following receipt of the Invoice/Statement.
- B. Each account shall be paid in full, and no deduction shall be made by way of contra accounts or in respect of any claim against Freshmax NZ Ltd or for any other reason, unless agreement has been made on certain deductions with the appropriate Freshmax NZ Ltd representative.
- C. If payment is not made in accordance with Clause (a) the following charges may be imposed:
 - (i) Interest payable, at such rates as Freshmax NZ Ltd may from time-to-time set on any account not paid from the due date until payment of all monies due.
 - (ii) Costs, including any costs incurred in collecting this debt in the event of non-payment.
 - (iii) If any amount remains overdue after thirty (30) days then an amount of the greater of twenty dollars (\$20.00) or ten percent (10%) of the amount overdue (up to a maximum of two hundred dollars (\$200.00)) shall be levied for administration fees which sum should become immediately due and payable.
- D. All payments shall be applied first in reduction of interest and any costs incurred under clause (C), the balance then being applied to reduction of any amounts outstanding under Clause (A).
- E. I/We acknowledge and agree that Freshmax NZ Ltd may:
 - (a) obtain credit reports from credit reporting or other credit providers for the purpose of assessing this and any other application made for credit
 - (b) obtain information from any other credit providers from time to time for the purpose of reviewing and assessing creditworthiness.
 - (c) disclose or discuss with any credit providers or any credit reporting agencies, any prospective guarantor and any person or body agreeing or considering whether to agree to be liable for any credit made available, any information maintained or in our possession relating to this application.
